PROPOSAL: The Federal Aviation Administration (FAA) is conducting a Non-Rulemaking study on a proposal to decommission the Tekamah (TQE) Runway 33, Runway End Identifier Lights (REIL), located at the Tekamah Municipal Airport, Tekamah, Nebraska. FAA Technical Operations has requested the REIL system be decommissioned due to excessive costs associated with the age of the equipment, which causes increased difficulty to obtain replacement parts in order maintain operational availability and due to the location of the facility, which is not in close proximity to the FAA Technical Operations System Support Center. This equipment will be removed without replacement should the study show that decommissioning the TQE REIL would not be detrimental to the National Airspace System.
