We have submitted nineteen (19) grant proposals totaling \$1,370,568 for fiscal year 2021-22. \$71,621 of this has been approved and \$531,563 is pending.

## **Funding Notices**:

We received funding notices on several of the Sept 30 round of worker training grants. These include:

- THIO Industrial was funded \$7,360 for welding training. Doug Pauley is the CCC lead.
- MetalQuest was funded \$1,260 for leadership training. Sandy Samuelson is the CCC lead.

Four worker training grants were not funded. These included:

## **Projects Submitted**

Two new grant/award applications were submitted this past month.

- \$7,500 requested from the Nebraska Rod & Custom Association to help fund an ADAS Calibration System for the Auto Body Program. This project is led by Mike Hoskins, Allison Feeney and Nate Allen.
- An award application was submitted to the World Federation of Colleges and Polytechnics for an Award of Excellence in the Sustainable Development Goals category. This award application is led by Ben Newton.

## In Development

- Catholic Climate Covenant, \$3,000 to support the Native American Curriculum Project. Led by Ronnie O'Brien.
- Science Education Partnership (SEPA), \$2,000 to support the Native American Curriculum Project. Led by Ronnie O'Brien.
- American Association of Community Colleges (AACC), Cyber Skills for All, \$20,000, led by Roxann Holliday, Brian Hoffman and Michelle Setlik.
- US Economic Development Administration (EDA) Good Jobs Challenge. This is a collaboration led by the Nebraska Manufacturing Alliance and the Nebraska State Chamber of Commerce. This project is still in the early conceptualization phase.
- Nebraska Dept of Education, Perkins reVISION Refresh. We will be looking at our original Perkins application from two years ago and utilizing input from advisory board meetings and CCC faculty and staff will determine if any changes or updates are necessary moving forward.
- Mini-Grants Solicitation and Awards for Fall 2021 (internal) two mini-grant applications were submitted for consideration. The committee will meet next week to review and make funding recommendations.

We continue to review new grant opportunities each day and send them out to everyone as appropriate. We realize we cannot apply for each and every opportunity that arises, but I encourage you to review them in a timely manner and let us know right away if you are interested in either learning more or developing an application. The turnaround time on most grants is fairly short, so it is important to get started as soon as possible.
