### Lawmakers convene for 2022 session

On a sunny, but bitterly cold morning Jan. 5, lawmakers gathered in the George W. Norris legislative chamber for the first day of the 2022 legislative session, which is a 60-day, or short, session. Lawmakers introduced 112 bills on this first day of a 10-day bill introduction period, which ends Jan. 20. In addition, they will be considering 490 bills and 33 resolutions that were carried over from last year's 90-day session. In the opening moments of the session, Sen. John McCollister of Omaha read part of an address that the late Sen. George W. Norris, who served in the U.S. Senate for 30

years, delivered on the opening day of the first Unicameral Legislature in 1937. Norris is widely regarded as the father of the one-house Legislature.

Speaker of the Legislature Mike Hilgers welcomed his colleagues back and said the Legislature will "knock the rust off right away" and proceed with all-day floor debate next week before committee hearings begin Jan. 18.

"We have a lot to do this session," he said. "I look forward to working with you all on a successful session this year."

### Several League bills introduced in first week of session

The 107<sup>th</sup> Legislature, Second Session, began its work Jan. 5, 2022. During the first 10 days of the legislative session, new bills can be introduced.

Several bills the League Executive Board voted to **support** have been introduced this first week including:

- LB 742 (Erdman) Provides for minutes to be kept in an electronic record under the Open Meetings Act. The bill allows all public entities to keep minutes in written form or as an electronic record. Currently, only minutes of the meetings of the board of a school district or educational service unit may be kept as an electronic record.
- LB 790 (Groene) Changes provisions of the Community Development Law relating to redevelopment plans receiving an expedited review. This bill makes several changes to "micro-TIF" including: allowing vacant lots located within a substandard and blighted area that have been platted for at least 60 years to be eligible for micro-TIF; increasing the amount for a redevelopment project of a single-family dwelling from \$250,000 to \$350,000, a multi-family or commercial structure from \$1-5 million and increasing from \$10 million to \$15 million for a redevelopment project involving the revitalization of a structure included in the National Register of Historic Places; and increasing the

length of a micro-TIF project from 10 to 15 years.

- LB 796 (Urban Affairs Committee) Changes reporting requirements under the Community Development Law. This bill adds the "amount of outstanding indebtedness related to each such redevelopment project and an estimated date by which such indebtedness is expected to be paid in full" to the list of items to be included in the report to the city council or village board.
- LB 797 (Urban Affairs Committee) Provides for the removal of certain blighted designations under the Community Development Law. This bill provides that upon a finding that an area is no longer substandard and blighted or extremely blighted, the city council or village board must declare by resolution that the area is no longer substandard and blighted or extremely blighted.
- **LB 798** (Urban Affairs Committee) Changes provisions relating to extremely blighted areas. LB 798 provides that the designation of an area as an extremely blighted area is valid for a period of 25 years from the effective date of the resolution declaring the area to be an extremely blighted area.
- LB 799 (Urban Affairs Committee) Changes provisions of the Municipal Density and Missing Middle Housing Act.



This bill adds information to be included in the report from the city to the Urban Affairs Committee of the Legislature. The new language provides that "the percentage of areas within the corporate limits in the city zoned for residential use which permit the construction of multifamily housing and middle housing, including whether these areas are zoned specifically for residential use or generally allow residential use, and whether such construction is permitted with or without any additional permit requirements" must be included in the report.

**LB 836** (Hunt) Requires a review of substandard and blighted area designations and extremely blighted area designations. With the bill, on or before July 1, 2024, and on or before July 1 of every fifth year thereafter, each city containing an area that has been designated as a substandard and blighted area or an extremely blighted area for more than 30 years must review the area to determine whether

the area is still eligible for that designation. Removal of the designation will not affect the validity of any redevelopment plan or redevelopment project involving the area that was approved prior to the removal of the designation or any bond, security for such bond, redevelopment contract, or agreement relating to a redevelopment plan or redevelopment project

• LB 842 (Brewer) Authorizes grants of assistance to tribal governments under the Civic and Community Center Financing Act. The bill defines tribal governments as the officially recognized government of any Indian tribe, nation, or other organized group or community located in the state exercising self-government powers and recognized as eligible for services provided by the United States to Indians because of their status as Indians or any Indian tribe located in the state and recognized as an Indian tribe by the state. The term includes any economic development corporation owned by or chartered by a tribal government. As background, the League was contacted about this change to the CCCF Act because the tomahawk once owned by Chief Standing Bear is returning to his Nebraska tribe after decades in a museum. Members of the Ponca Tribe in Nebraska are working to repatriate the artifact and build a museum to house the tomahawk.
