## 2022-2023 Replacement

1. Remove the 2001 Van from the fleet. It is rarely used due to the amount of work it needs. It primarily sits by the water treatment facility and when used is for cargo purposes only. It has no seats and needs significant work on the front end.
  - a. Replace this vehicle with a 10+1 passenger van that can be used for activities.
  - b. Potentially move Van A to fill the cargo van role.
2. Remove the 2007 Green Ford Taurus. Rarely used due to needing a new serpentine belt, leaks oil, needs new struts, and has significant hail damage.
  - a. Replace this vehicle with a sedan or minivan sized vehicle
3. Move the 2012 Silver Dodge Minivan to the regular fleet of activity vehicles.
  - a. Replace this vehicle with a minivan purchased with special education funds to only be used for special education purposes.

#### 2023-2024

1. Remove the 2007 Tan Ford Taurus. Vehicle runs and gets used but is nearing the end of its life without significant repairs/updates. These include: breaks will need replacing, struts, body is showing more and more rust, interior order is pretty gross
  - a. Replace with sedan or minivan.
2. Retire the 2003 Dodge Ram
  - a. Replace with a half ton pickup that has the power liftgate on the back.
  - b. Replace with a ¾ ton pickup that has power liftgate on the back and could be used to plow snow (would require blade addition)

#### 2024-2025

1. Retire Van D from the fleet and replace with a 10+1 passenger Van

#### 2025-2026

1. Retire Van C from the fleet or move it to be a cargo van. If it becomes the cargo van then remove Van A from the fleet.
  - a. Replace with a 10+1 Passenger Van

#### 2026-2027

1. Retire Van B from the fleet
  - a. Replace with a 10+1 Passenger Van
