We hereby submit specifications and estimate for:

**REPLACING ROOF SECTIONS AREA: BID PRICE: \$84,000**

HRC TO PROVIDE ALL MATERIALS, LABOR AND EQUIPMENT TO PERFORM THE FOLLOWING:

## SCOPE OF WORK TO INCLUDE:

1. Remove existing roofing down to deck.
2. Mechanically attach 2" Iso to deck.
3. Adhere 1/2" High Density cover board to Iso insulation in adhesive.
4. Install .60 mil EPDM membrane over field of roof, adhered in adhesive.
5. Install .60 mil EPDM membrane and boots at all wall and projection flashings.
6. Install new Kynar metal at perimeter edge, wall terminations, etc as needed.
7. Clean up and haul away all debris.
8. Provide 20 year manufacturer's warranty.

## ROOF SYSTEM DOES NOT INCLUDE:

1. Mechanical or electrical work related to moving, replacing or altering HVAC RTU's.
2. Precise relocation of any satellite, radio or television antennas.
3. Utility connections needed for either disconnect or reconnect, i.e., natural gas, water, electrical power, etc.
4. Deck repair or replacement over 2,500 sq.ft.

We hereby propose to furnish labor and materials—complete in accordance with the above specifications, for the sum of Eighty Four Thousand Dollars (\$84,000) with payments to be made as follows:

**30% down at contract signing, 2 progress payments as project is completed**

All material is guaranteed to be as specified. All work to be completed in a workmanlike manner according to standard practices. Any alteration or deviation from above specifications involving extra costs will be executed only upon written orders, and will become an extra charge over and above the estimate. All agreements contingent upon strikes, accident or delays beyond our control. This proposal subject to acceptance within **10** days and it is void thereafter at the option of the undersigned.
