The Seward City Council met at 7:00 p.m. on Tuesday, October 18, 2016, with Mayor Joshua Eickmeier presiding and Assistant Administrator /Clerk-Treasurer /Budget & Human Resources Director Bonnie Otte recording the proceedings. 9. CONSIDERATION OF A RESOLUTION AMENDING THE FEES CHARGED AT THE SEWARD CEMETERIES

Greg Zabka, 1768 Karol Kay Blvd, addressed the City Council as a member of the Cemetery Board with a resolution proposing an increase in fees for all City of Seward cemeteries. He stated the Cemetery Board and City staff has been working on this project for over a year and surveyed surrounding communities resulting in the proposed increases. He added that the last increase took place ten years ago. He stated the proposed increases are not based on a percentage increase but rather based on the survey. The survey was included in the information presented to the City Council for review.

Councilmember Singleton introduced the following resolution:

RESOLUTION NO. 2016-21

WHEREAS, the City Council of the City of Seward, Nebraska may by resolution fix the amount of Cemetery fees, and

WHEREAS, it is deemed advisable to establish Cemetery use fees;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SEWARD, NEBRASKA THAT:

The amount of Cemetery fees shall henceforth be and are hereby fixed as follows to be in full force and effect on and after January 1, 2017:

Holidays in which the City will provide services for an additional fee: Martin Luther King Jr. Day (third Monday in January), Labor Day (first Monday in September), and Veterans' Day (November 11).

Holidays in which no services or openings will be conducted: New Year's Day (January 1), Memorial Day (last Monday in May), Independence Day (July 4), Thanksgiving Day (fourth Thursday in November), and Christmas Day (December 25).

All fees will be reviewed in 3 years.

All previous resolutions in conflict with this resolution are hereby revoked.

10. CONSIDERATION OF AMENDMENT NO. 1 TO THE AGREEMENT WITH SCHEMMER ASSOCIATES FOR WAVERLY ROAD, HIGHWAY 15 TO KAROL KAY BLVD

Public Facilities/Capital Improvements/GIS Director John Hughes presented an amendment to the agreement with Schemmer Associates for the Waverly Road, Highway 15 to Karol Kay Blvd, indicating that at the time the original agreement for engineering services was signed, Seward County's portion of the project to Plum Creek Bridge was not included in the design. Seward County has since expressed interest in piggy-backing onto the City's project to save in total costs for mobilization and bidding out a larger project. He stated the additional cost for the engineering is \$2,800.

Councilmember Kamprath inquired about the change of placement of the proposed trail from the north side of Waverly Road to the south side and how this would impact the property owners who are building homes in this area. He stated the City purchased property for the easement on the north side and now the easement won't be used.

Mr. Hughes stated the City did purchase the property for plans to construct a water line for the elementary school. At that time, there was to be no mention that this property would be used for the trail project; however, plans for the trail did get included in the discussions. Because this is a federally funded and Nebraska Department of Roads (NDOR) project, there were certain requirements or steps that had to be followed in acquiring the property and this did not happen, so the Nebraska Department of Roads will not approve that trail placement, as originally planned. He stated that the current proposal is to move Waverly Road to the north approximately eight feet and have the trail run along the south side of the road. He added that this plan does not affect the lot size of the property owners on either side of the road, but the lot owners are required to provide for right-of-way.

Councilmember Kamprath indicated the proposed changes are considerably different from the original project plan and he would like to see specifics on the changes and information received that states the project cannot move forward as originally designed.

Moved by Councilmember Schmit, seconded by Councilmember Kamprath, that Amendment No. 1 to the Schemmer Associates for the Waverly Road, Highway 15 to Karol Kay Blvd project be tabled to another meeting in order to gather additional information.
