### 3. PRESENTATION BY D.A. DAVIDSON ON PAST YEAR REFINANCING AND BOND SALE

Paul Grieger, D.A. Davidson & Company, presented an update on the 2016 Bond Issues, which included Highway Allocation of \$825,000; General Obligation Refunding \$1,085,000; Water System Revenue Refunding \$1,220,000; Sewer Refunding and Plum Creek Project \$4,155,000; and Electric \$5,365,000 Refunding of \$5,365,000. The net present value of savings to the City on the issue refunding was \$747,309 and did not extend the final maturity dates for any of the reissues. No action was required or taken.

#### 4. PRESENTATION BY NEBRASKA MUNICIPAL POWER POOL ON UTILITY RATE SERVICE STUDY

Phil Euler, Nebraska Municipal Power Pool, provided the rate study analysis for electric, water and sanitary sewer services. Based on the analysis, there is no proposed rate increase for electricity for October 2016 or 2017, no proposed rate increase for water for 2016, but a 3.0% proposed increase in October 2017. Mr. Euler stated the analysis indicates a need to increase the sewer rates by 6.3% in October 2016 and an additional 5.8% in October 2017.

City Administrator Smith stated that there will be a 1.9 million correction to the 2015 audit in which this dollar amount will be deducted from the Water Utility and transferred to the Electric Utility, correcting a transaction which showed Electric Bond proceeds as Water Bond proceeds. Mr. Smith stated, there is a proposal to increase the franchise fees for the electric utility from 5% to 10%, which would be reflected in the next budget year. Mr. Euler stated that this could result in stretching the need for an electric rate increase out one additional year, but would not affect a 0% increase for water in October 2016.

There was a brief discussion about the language in the proposed Sewer Ordinance and also that the title of the Ordinance needed to be corrected to a 5.8% increase in October 2017 (listed as 5.3%).

Ordinance No. 2016-14 amending Section 3-227 of the City Code, initiating a 6.3% increase in sewer system service rates effective October 2016 and a 5.8% increase in sewer system service rates effective October 2017 was adopted (noting correction in title from 5.3% to 5.8% and removing the word "which" in the first line of the paragraph directly above Section 2).

Councilmember Schmit moved, seconded by Councilmember Wilken, that the minutes of the proceedings of the Mayor and Council of the City of Seward, Seward County, Nebraska in the matter of passing and approving **Ordinance No. 2016-14**, "AN ORDINANCE TO AMEND SECTION 3-227 OF THE CITY CODE; TO INITIATE A 6.3% INCREASE IN REVENUES CHARGED TO CUSTOMERS FOR SERVICE FROM THE SEWER SYSTEM OF THE CITY EFFECTIVE WITH THE OCTOBER 2016 BILLING AND AGAIN INCREASE IN REVENUES OF 5.8% IN OCTOBER 2017; TO PROVIDE FOR BILLING THEREOF; TO REPEAL THE ORIGINAL SECTION 3-227; TO PROVIDE FOR A TIME WHEN THIS ORDINANCE SHALL TAKE EFFECT" be preserved and kept in a separate and distinct volume known as "Ordinance Record, City of Seward, Nebraska" and that said separate and distinct volume be incorporated in and made a part of these proceedings the same as though it were spread at large herein.

Councilmember Wilken moved, seconded by Councilmember Schmit, that the minutes of the proceedings of the Mayor and Council of the City of Seward, Seward County, Nebraska on August 2, 2016, in the matter of passing and approving **Ordinance No. 2016-13**, "AN ORDINANCE TO ESTABLISH A DOG PARK IN THE CITY OF SEWARD; ESTABLISH RULES FOR DOG PARKS; AMEND THE POLICE REGULATIONS; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND TO PROVIDE FOR AN EFFECTIVE DATE" be preserved and kept in a separate and distinct volume known as "Ordinance Record, City of Seward, Nebraska" and that said separate and distinct volume be incorporated in and made a part of these proceedings the same as though it were spread at large herein.

### 5. CONSIDERATION OF CLAIM OF FOX DEN RENTALS, LLC, CHARLES LIESKE, 3533 SPRUCE DRIVE, SCOTTSBLUFF, FOR PERSONAL PROPERTY DAMAGE AT 407 SOUTH STREET, SEWARD

City Administrator Smith stated the City received a claim against the City in the amount of \$1,432.90 for reimbursement of costs to a rental property located at 407 South Street, related to a sewer backup beginning on the weekend of April 4, 2015 continuing through October 3, 2015. Mr. Smith stated Mr. Lieske claims the backup was caused by a collapsed clay sewer pipe and additionally, blockage in the City main. Mr. Lieske is not claiming reimbursement for damage to the property, but for reimbursement for costs in hiring several plumbers to determine the cause of the backup.

Councilmember Singleton moved, seconded by Councilmember Schmit, that the claim of Fox Den Rentals, LLC, Charles Lieske, for personal property damage at 407 South Street be denied and forwarded to the City's insurance carrier for disposal.

# 6. CONSIDERATION OF AUTHORIZATION TO ADVERTISE FOR QUOTES FOR WATER TREATMENT PLANT REVERSE OSMOSIS MEMBRANES

City Administrator Smith stated the reverse osmosis membranes at the treatment plant have never been replaced and the typical life is 5-7 years. He stated these membranes have been in place for 12 years. The estimated cost to replace the membranes is \$135,000, of which a partial grant from the Upper Big Blue has been awarded.

Councilmember Singleton moved, seconded by Councilmember Fritz, that the City be authorized to advertise for quotes for replacement of the water treatment plant reverse osmosis membranes.
