## State Board Executive Committee Running Record

February 1, 2024

The State Department of Education, provided for in Article VII, Section 2 of the Constitution of Nebraska, shall have the general supervision and administration of the school system of this state and of such other activities as the Legislature may direct. The State Board of Education, acting as a unit, shall be the policy-forming, planning, and evaluative body for the state school program under Section 79-301.

Per State Board Bylaw 4: Board Committees, the executive committee shall be charged with advising the commissioner on legislative matters while the state legislature is in session and making recommendations to the Board on the NDE's position on specific bills and legislative resolutions.

*The purpose of this document is to report on legislative activity since the previous meeting, outline bills under consideration in the following week(s), and advise the commissioner on legislative matters.*

### Board Priority Areas:

1. Increase Third Grade English Language Arts Proficiency to 75% by 2030
2. Halve the Gap in 8th Grade Math Achievement for Each Student Group by 2030.
3. Increase the Number of High School CTE Concentrators to 50%.
4. Reduce Chronic Absenteeism by Half by 2030
5. For Youth who are Systems-Involved, Raise the High School Graduation Rate and/or High School Equivalency Attainment to 70%.
6. Eliminate the Special Education Staffing Vacancy and Cut the Educator Shortage in Half by 2030.
