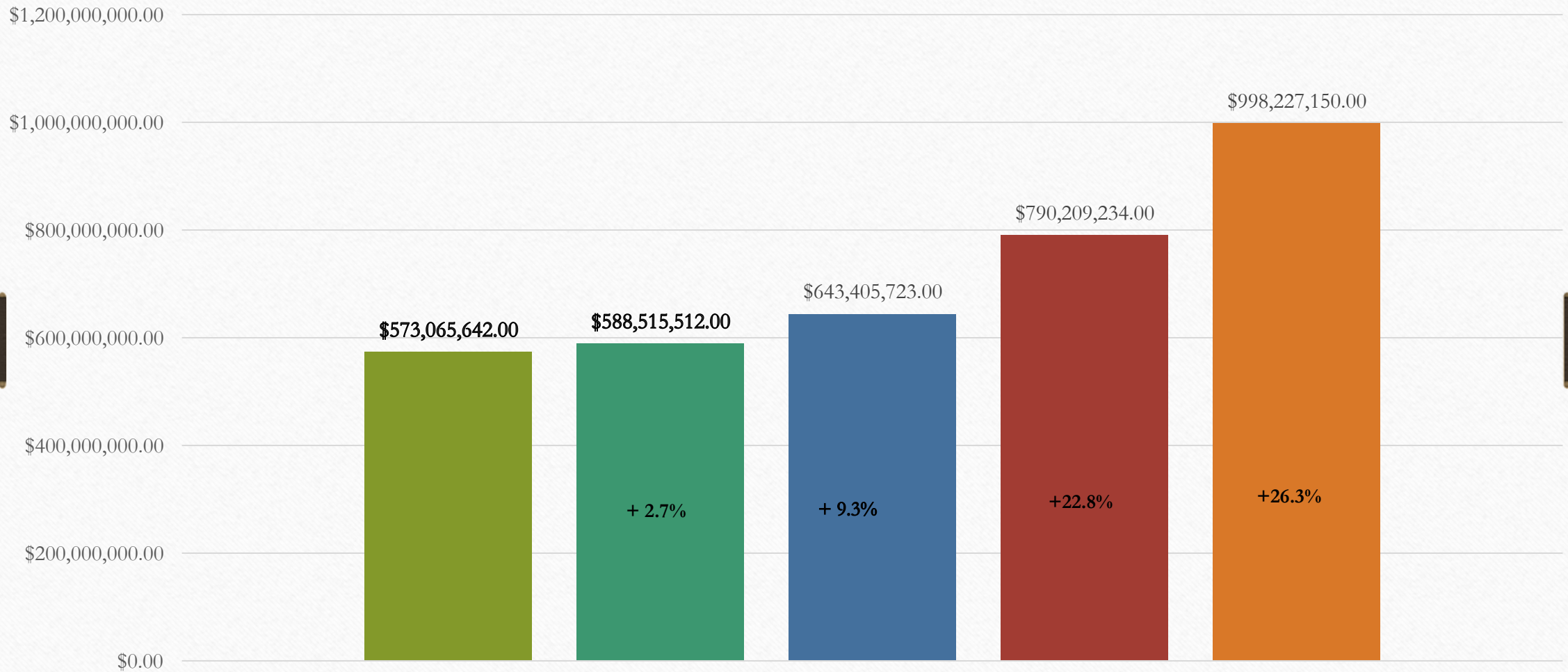

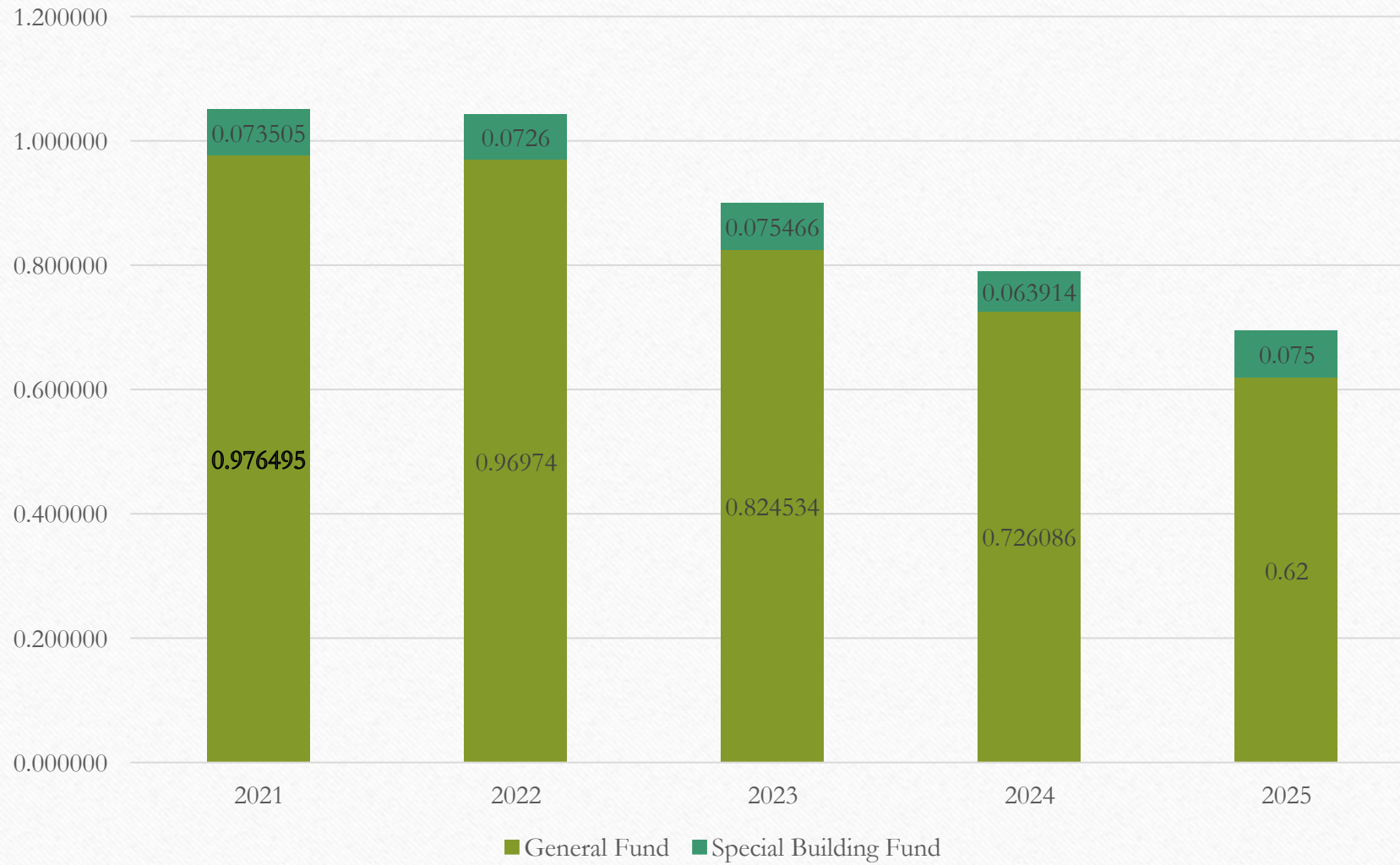
Valuations in Kimball County



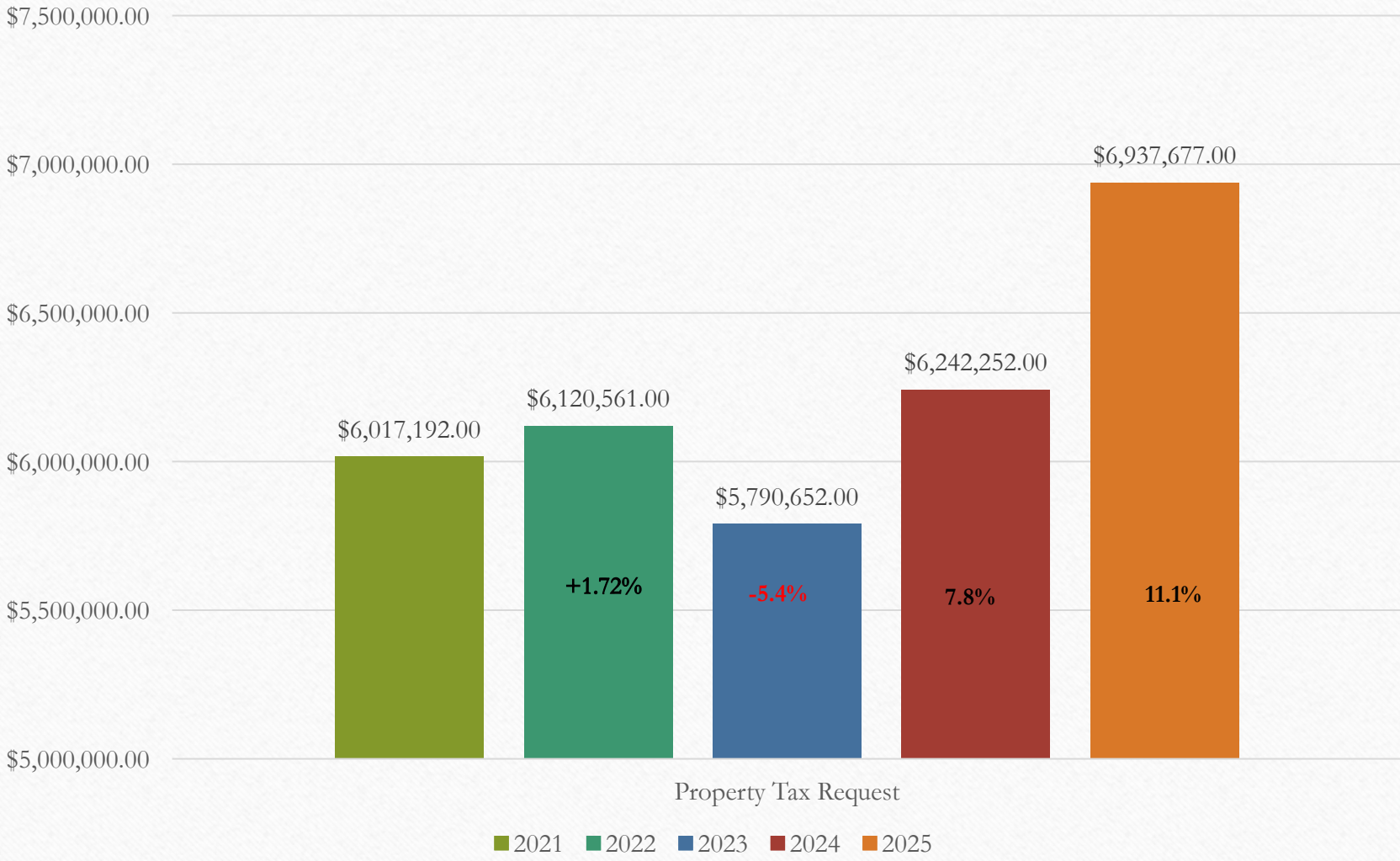
Kimball County Valuations

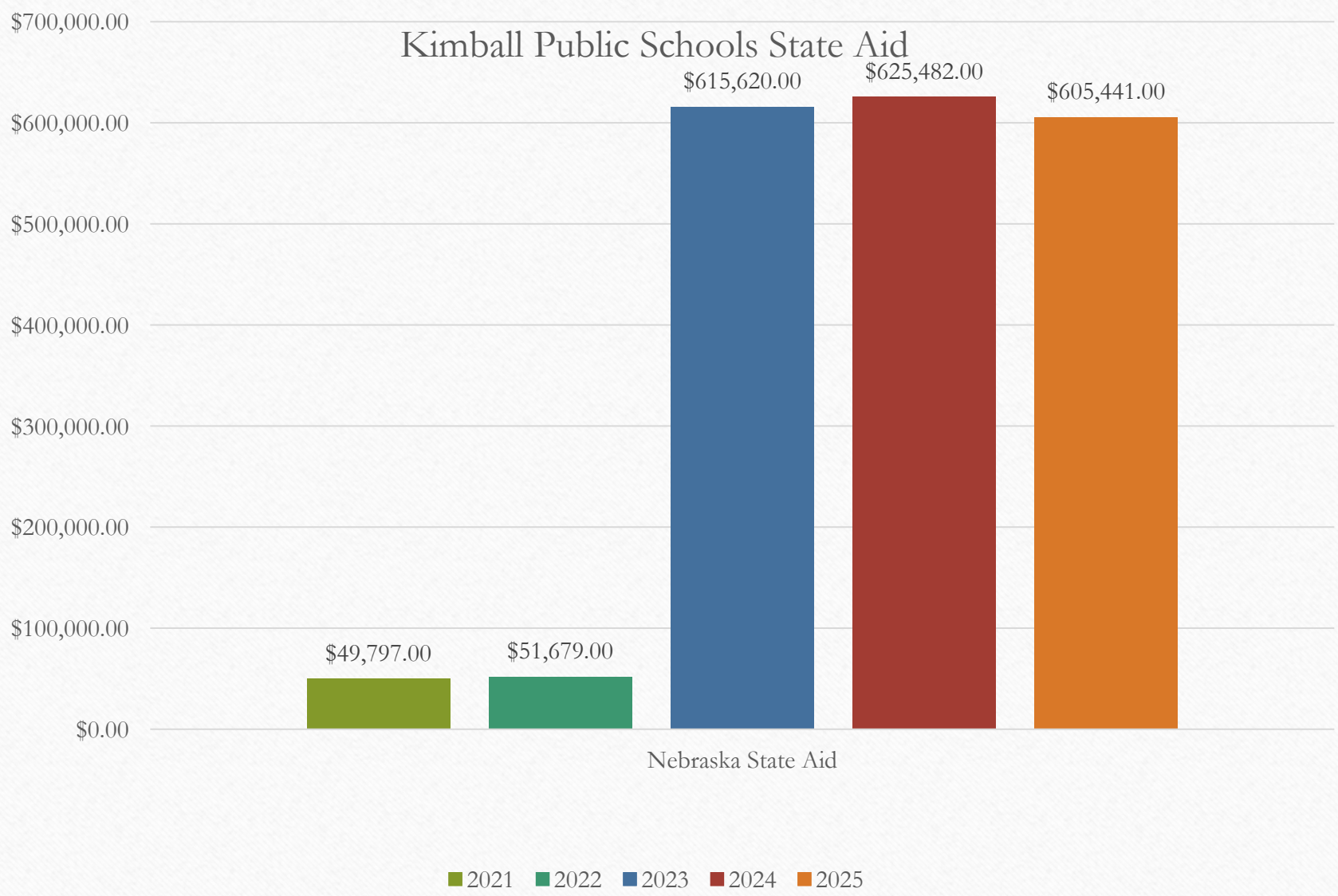
Kimball Public Schools Property Tax Rate

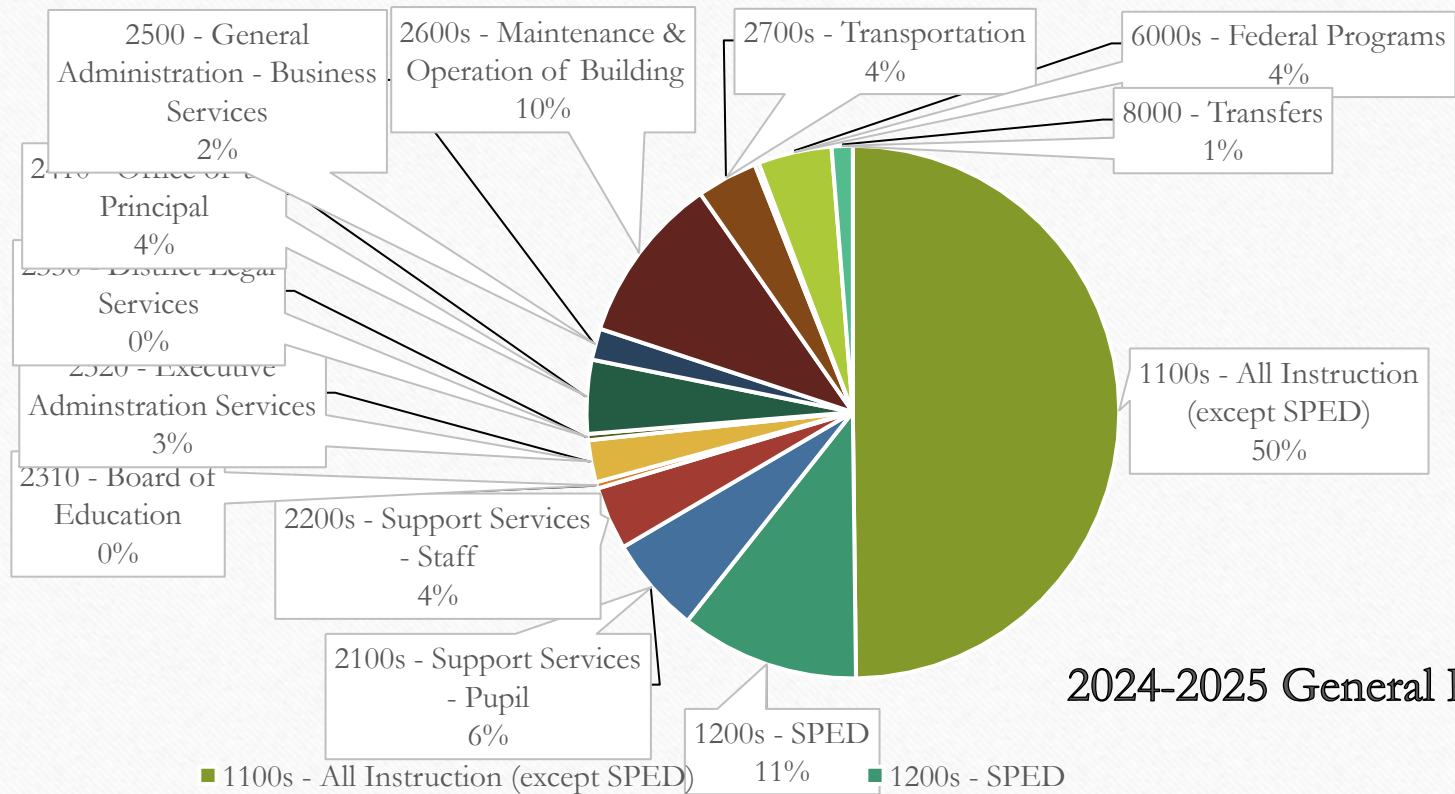


Kimball Public Schools Property Tax Request



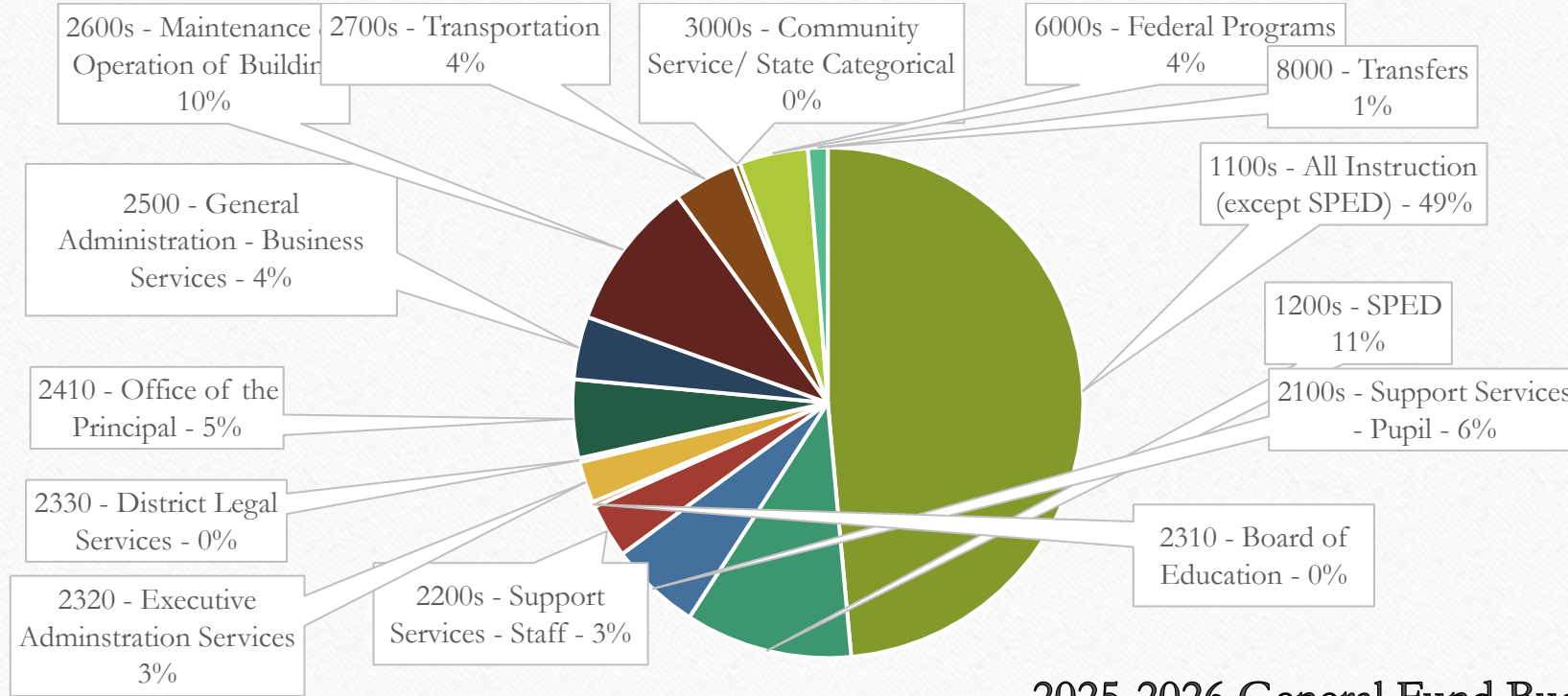
Kimball Public Schools State Aid
