A. CALL TO ORDER: President Hoops called the Regular Board Meeting to order at 7:30p.m.

E. ACKNOWLEDGE POSTED OPEN MEETING ACT: President Hoops announced and informed the public that a current copy of the Open Meetings Act is posted on the wall of the meeting room and directed the public to its location.

A. APPROVAL OF PRIOR MINUTES: The Board reviewed the minutes from the June board meeting. Motion(Feurer) Second (Swanson) to approve June meeting minutes.Motion Carried 6-0.

B. REVIEW OF FINANCIAL STATEMENTS: The Board reviewed the financial statements and the Activity Fund statements.

C. APPROVAL OF BILLS: Motion (Feurer) Second (Emanuel) to approve the bills for July. General Fund \$121,551.67, Building Fund - \$119,642.72 Motion Carried 6-0.

6. REPORTS:

A. SUPERINTENDENT REPORT: Mr. Ningen reported:

- Our elementary teachers have been busy this summer completing the state-mandated Nebraska Reading Improvement Act training through our local ESU and in-state colleges. Because this program requires extensive hours outside of class collaborating and working with students, I would like to propose a fair compensation structure under our Negotiated Agreement. Typically, staff earn \$25 per hour for extra work, but they cannot "double-dip" by claiming this rate for class time that also counts as self-funded college credit for salary schedule advancement. Since the practicum work directly impacts our curriculum and students, my proposal separates class time from outside application. Teachers taking the course for college credit would pay their own tuition and only be paid the hourly rate for their prep and student-contact hours completed outside of regular class time, unless covered by a grant. Conversely, teachers choosing not to take the course for credit would be paid the \$25 hourly rate for their entire time commitment, including both class sessions and outside project work. This approach fully respects our Negotiated Agreement while rightfully compensating our staff for the rigorous

workload this mandate requires. No approval is needed for this....I just wanted you to be aware and to see if you had any questions.

- I have reached out to two additional installers of BDA (Bi-Directional Amplifier) systems for our radio problems in both buildings. I heard back from one (Aaron Nichelson from Midwest Alarm Services) and he is working to get us a quote. Bob Stephany did reach back out to me as well, and said a total, more accurate estimate would not be available without doing a full building scan. From him, this was the \$8000 cost.
- Dirt work and site preparation has begun at the elementary addition build location. We will have construction update meetings every two weeks.
- The restroom/concession stand building has successfully transitioned from rough-ins to the interior finish phase, highlighted by passing both the Dodge County framing inspection and the State electrical inspection. As of early July, rough grading, HVAC rough-ins (including mini-split head units for the restrooms and concession area), insulation, and drywall hanging are all complete. Current work for the week of July 6 includes drywall finishing, the arrival and installation of remaining door hardware, and the installation of the main garage door, roll-up concession doors, and concession window countertops. Looking ahead, interior painting, FRP, and restroom partitions are scheduled to begin the week of July 13 alongside the exterior walking path, setting up the project for final plumbing and electrical finishes the week of July 20.
- I was able to run a recent negotiation array comparison for our teacher pay, as almost every school in our array (except Arlington) has settled and been entered into Sparq. We currently sit 3rd in our array, just behind West Point and ahead of Logan View, at the 102.44 percentile. DC West is first, by a long way. This is an improvement for us, as we had been in the 100-101 percentile range for the last 6+ years.

The board reviewed what information they have currently and plan to approve at the August board meeting. Both companies said they could have the landscaping done by this fall.

DISCUSS 2026-2027 BUDGET PRESENTATION:** The board reviewed the recent budget document from the state and an estimated budget amount for 26-27, which included a comparison of our general fund budgeted expenditures for the last two years, along with the proposed general fund items for the upcoming year. The total amount proposed matches what was discussed at the board work session back in March. The overall proposed increase is 5%.
- G. DISCUSS SPECIAL BOARD MEETING IN AUGUST, FOR THE PURPOSE OF APPROVING FUND TRANSFERS AND EXCEEDING OUR PROPERTY TAX REQUEST AUTHORITY:** Mr. Ningen proposed to vote to exceed and not use the funds, thus allowing the funds to carry over for usage the following year. This has been done for the last two years and this approach has been recommended by NASB.

Board Report

August 10, 2026

Back to School Blast - On August 6th, we hosted our Back-to-School Blast. The event ran from 8 am to 6 pm. Once parents filled out the Online Registration, which included all the back-to-school forms, students were encouraged to come to school to receive their school-issued devices, athletic locker, pay lunch money, and see their schedules. We promoted this event through our website, social media, and Thrillshare.

Media Day - We are trying another approach to Media Day this year. As in the past, with the Back to School Blast, we would miss several students, as some families were in progress or families decided to take one last quick getaway before school started. This year, we moved Media Day to Tuesday, August 12th, after the start of fall practices. All fall sports are scheduled with time slots for group and individual photos.
