School Board Regular Meeting

May Events:

Elementary Track and Field Day - May 12th 12:00-3:00: Mr. Kuhn organized the event. The weather was amazing. The ribbons were handed out at the next day's Morning Meeting. The graduating seniors that assisted contributed to the organization of the event. 3-5 faculty members also were key in running the various events.

Little Feet Meet Field Day - May 18th 9:00-10:50 and 11:45-1:15: This was organized by Stacy Stewart and the K-2 faculty members. Mrs. Stewart worked with the Nebraska Special Olympics organization to create the field day. NSO provided free t-shirts to the K-2 students and staff. Additionally, they donated equipment to the event and the school. The plan is to continue this event each year. The NSO representative at the event stated the event at S-RC was the most organized she had seen and been a part of. Ribbons were presented at the Morning Meeting on May 19th.

"RAMP It Up" Summer School is scheduled for July. Registration Forms were mailed to those students who were teacher recommended with high needs and those who would also benefit from a jump start to the 21-22 school year. The response from parents has been slow. Registrations will continue to be accepted through the month of June. Staff is meeting to set up the lessons/curriculum and schedule for each of the days. Mr. Stewart will work with Mrs. Glock to schedule transportation.

1. **Band**

- a. We will certainly have a journey this year as newcomers to the school! The band returns to marching this year after a no-marching year due to COVID, and we are planning an out-of-state trip in summer 2022 so it's a big year for the music department.
- b. I believe there are 105 uniforms in total and not sure on the dates for the last cleaning. There is a list of students & assigned uniform numbers but I don't know when the other uniforms were last cleaned or if there would have been any swapping, so I feel that the most *hygienic* option would be to have them all cleaned and start fresh. Prestige Dry Cleaners in Columbus estimates \$1470 for cleaning 105 two-piece uniforms. Please let me know if we can go ahead, or if you'd like me to make calls to other dry cleaners. I believe all cleaners have a fairly similar pricing structure.
- c. Ken Hamsa of Ken's Band Instrument Repair in Norfolk will come and look at the instruments with me in the music room on Monday (6/14) and give an estimate for repairs. I've had Ken work on my instruments since the late 90s and he's fair and thorough. I'll send a few common instruments along with him but have him hold for approval on any repairs that are going to be more costly. I'll get you those numbers ASAP. *If you are available on Monday between 9am and 2pm when we are there I would love to have you come over and say hello and get acquainted.*

2. **Printer/Copier lease**

- a. 1 for 1 replacement upgrade for your copier lease that is due next month. As always – the new lease has the reduced service and supply rates to lower the cost of ownership on these machines. Based on the volumes you're currently doing, the school will save about \$60 per month on the new contract.

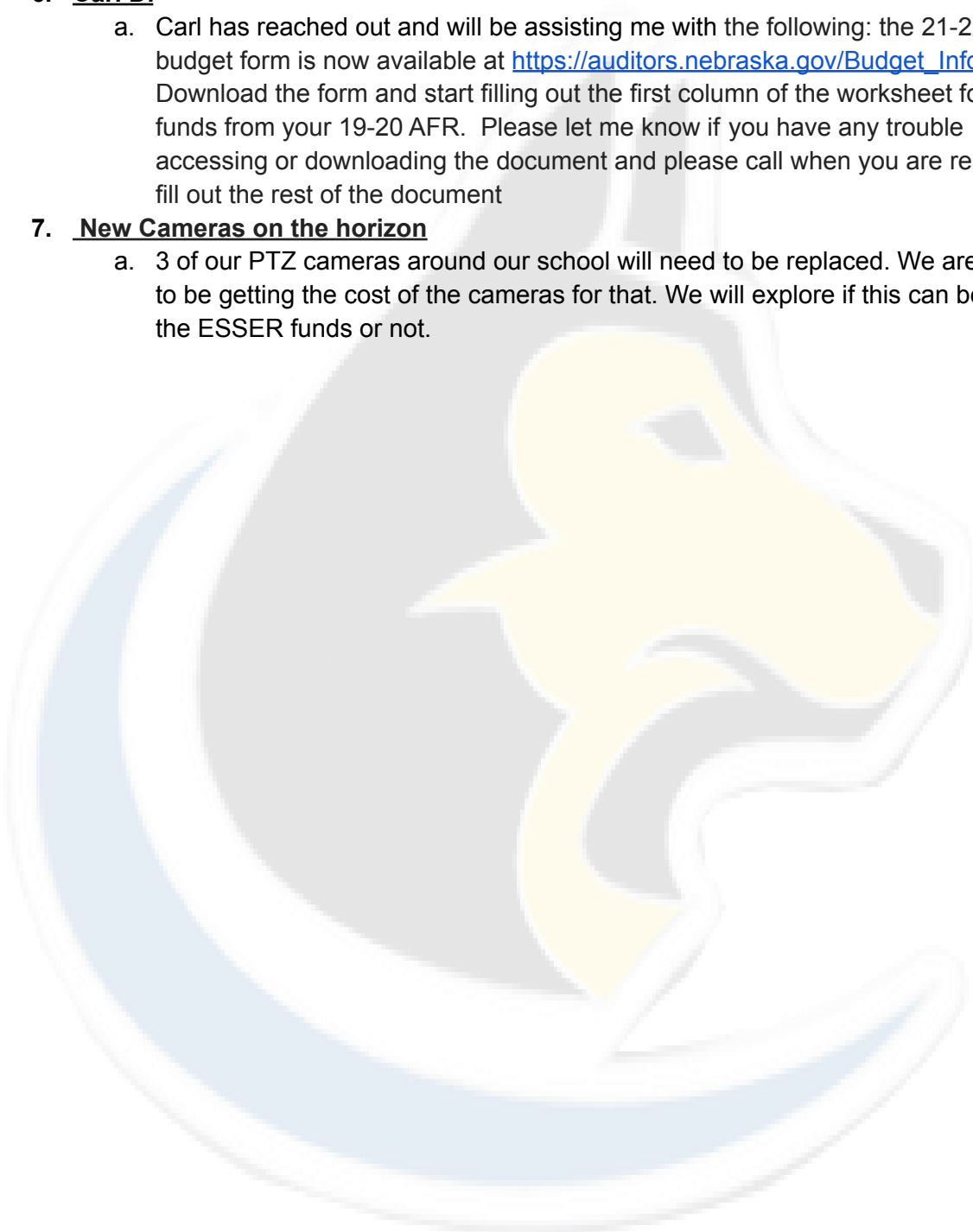
have now been revised again to reflect a change from LB 451 passed in the recent Legislative session.
