6.1. Superintendent's Report **Summary of the Superintendent Report:**

- **NDE Option Enrollment Presentation:** The board elected to have a special session dedicated to learning more about the option enrollment process and the impact it has on our district and state funding for education.
- **Behavior Posters:** Special thanks to our high school and elementary staff for creating building-wide discipline systems and posters that reinforce expected behaviors at each school.
- **Student Enrollment Update as of September 11, 2023:** There are **407** (pre-K-5) students at Bennet Elementary School, **329** students at the Jr./ Sr. high school, and **4** students in our Aspire Academy, for a total of **740** students.
- **Bennet Elementary School: Playground Update:** The Bennet playground continues to take shape and students are going to be able to visit various parts of the play area in the coming weeks. Sod and irrigation for the playground are getting ready to be put in (sod may have to wait until November due to current water restrictions in Bennet). Due to fluctuating interest rates, economic uncertainty, and projected volatility within the market, the second issuance was delayed.

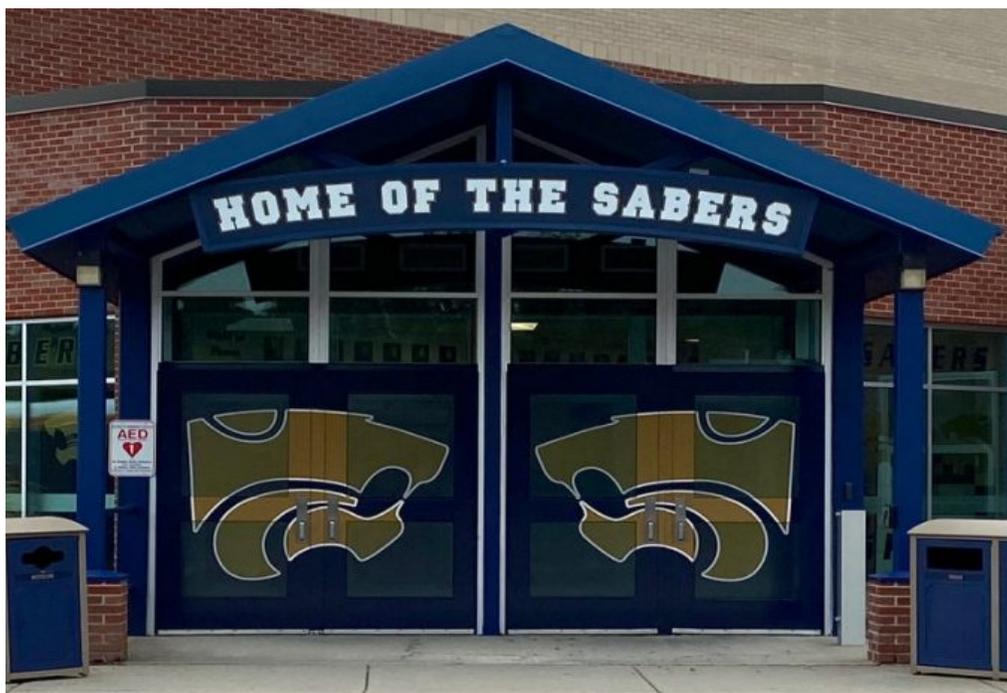

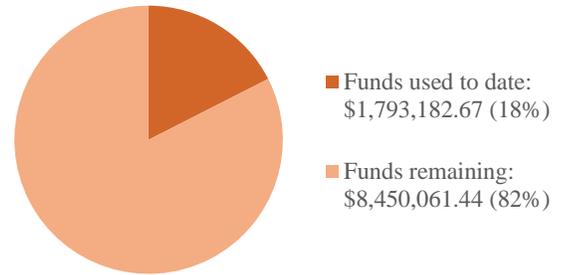

StudentsEarly Completion Plan

District OR-1 Public Schools supports the concept of early completion as a means of accelerating students toward the achievement of lifetime plans. The following guidelines have been established for students to be eligible for early completion. The failure to meet any of the criteria or time lines listed in the policy may cause the student to become ineligible for early completion.

- (1) A student will be allowed to transfer in a maximum of twenty (20) hours from educational courses taken outside the District OR-1 Public School District. These courses must have prior approval by the high school principal in order to be used to meet the graduation requirements of the District OR-1 Public Schools. Students transferring into District OR-1 Public Schools may transfer in hours that are listed on their official Transcript.
- (2) A student will be able to use only five (5) hours of transfer credit in any one subject matter area.
- (3) Students must meet all completion requirements established by the Board of Education in order to be eligible for completion as well as the credit hour requirements in each specific subject matter area.
- (4) Application for early completion must be requested, in writing, to the high school principal by March 15th of the applicant's Junior year of high school. The application must be accompanied by a written plan of action stating the reasons why the student is requesting early completion. The application must contain the signatures of the applicant's parents/parent/guardian to verify parental approval of early completion.
- (5) Along with the application, the applicant must submit three (3) letters of recommendation supporting the student's request for early completion. These three (3) letters of recommendation must contain one (1) letter from the high school guidance counselor, along with two (2) letters from other secondary staff members.
- (6) The Superintendent or designee will make the final decision in regards to an applicant's early completion prior to April 15th of the applicant's Junior year.
- (7) Once given approval, the applicant will have until March 15th of the applicant's Senior year to notify the high school principal of the applicant's decision in regards to participating in the regularly scheduled graduation ceremony. The applicant must also attend one (1) Commencement practice in order to participate in the Commencement

ceremony. No early graduation ceremonies will be provided for a student who opts for the early completion route.

- (8) A student who decided to opt for early completion is not eligible to participate in school sponsored activities following the last day the student attends classes. The effective date for participation will end with the last day that the student is enrolled in classes. The only school activity that the applicant is eligible for will be the regularly scheduled graduation ceremony.
- (9) This policy shall be evaluated annually by the high school principal and appropriate revisions shall be recommended to the Board for its consideration.
- 10) The deadlines listed may be waived by the Superintendent or designee when extenuating circumstances exist. Requests for waivers based upon extenuating circumstances must be submitted to the Principal and Superintendent at least 60 days prior to graduation.
- 11) The Superintendent will notify the Board of Education in advance of any students seeking early completion.

LB 243 Information and Process:

Background

- Nebraska recently enacted the School District Property Tax Limitation Act (the “Act”), which was part of LB 243 (2023) and is now codified at NEB. REV. STAT. §§ 79-3401 to 79-3408. The Act’s default rule is that the magnitude of a school district’s property tax request (irrespective of either the \$1.05 levy limit, or otherwise permissible budget growth) is limited to a statutorily-defined property tax request authority.
- “Property tax request means the total amount of property taxes for the general and special building funds requested to be raised for a school district through the levy imposed pursuant to section 77-1601.” NEB. REV. STAT. § 79-3402(6).
 - “Non-property-tax revenue means revenue of a school district from all state and local sources other than real and personal property taxes. Non-property-tax revenue does not include grants, donations, bonds, all revenue from a school district that has been merged into another school district or dissolved, activity funds, bond funds, cooperative funds, depreciation funds, employee benefit funds, nutrition funds, qualified capital purpose undertaking funds, or student fee funds, insurance proceeds, proceeds from the sale of property including land, buildings, or capital assets in special building funds, or proceeds of financing.”
- Base growth percentage means the sum of: **Three percent**
 - The annual percentage increase in the student enrollment of the school district multiplied by:
 - One if the school district's student enrollment has grown by an average of at least three percent and by at least one hundred fifty students over the preceding three years;
 - Seven-tenths if the school district's student enrollment has grown by an average of at least three percent over the preceding three years; or
 - Four-tenths if subdivisions (3)(b)(i) and (3)(b)(ii) of the statute do not apply:
- NDE certifies the amount calculated by this method to each school board as the district’s property tax request authority. A **Board Vote and written resolution** to Increase Base Growth Percentage allows for increasing the actual property tax request by a certain amount and allows the board to vote to increase the base growth percentage. This action has the effect of increasing the property tax request authority for the current year, and the absolute amount of the property tax request authority (in dollars) will depend upon the changes in the non-property-tax revenue for the current year.
- The proposed increase in the base growth percentage must be approved by at least 70% of the school board members.
- The maximum base growth percentage increase that a school district can adopt by a board vote depends on the size of the school district’s average daily membership using the “most recent” ADM numbers for each school district, which (for now) shows the numbers for the **2021–2022** school year.
- The maximum % increase corresponds to the size of the school.
 - **Up to 471 students 7%**
 - **472 to 3,044 students 6%**
 - **3,045 to 10,000 students 5%**
 - **More than 10,000 students 4%**

**RESOLUTION OF THE BOARD OF EDUCATION TO INCREASE BASE
GROWTH PERCENTAGE TO DETERMINE ITS PROPERTY TAX
REQUEST AUTHORITY**

WHEREAS, the Board of Education (“Board”) for **District OR School District 66-0501**, commonly known as **District OR-1 Palmyra- Bennet Public Schools** (the “School District”), is planning the School District’s annual budget for the **2023–2024** school year; and

WHEREAS, in an effort to maintain budget flexibility and to ensure the ability to secure adequate funding in the current or future school years so that the School District is in a position to meet its obligations to its students, the Board believes that it is prudent to increase the base growth percentage used to determine the School District’s property tax request authority under NEB. REV. STAT. § 79-3403 and

WHEREAS, Nebraska law authorizes the Board, upon an affirmative vote of at least seventy percent (70%) of the Board, to increase such base growth percentage by up to 6%.

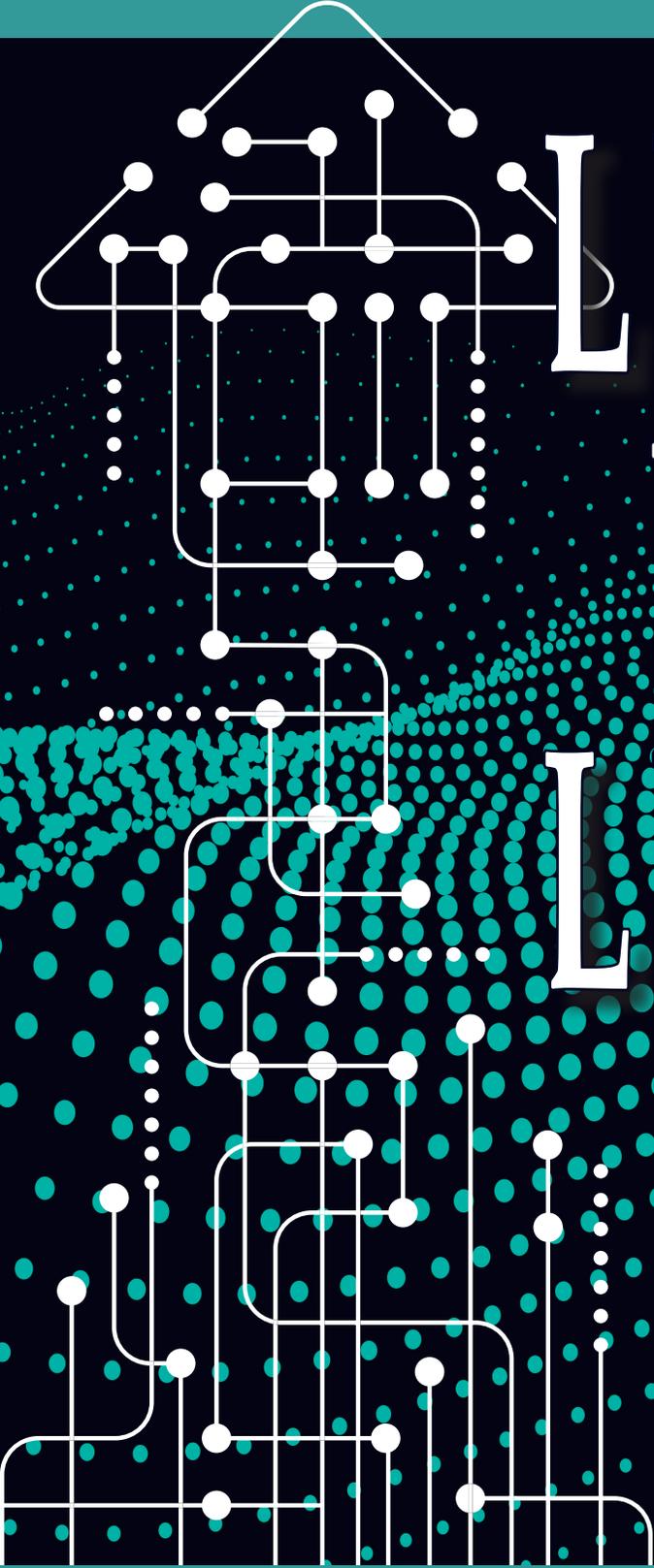
