With limited options to water the fields, the district has found an outside-of-city limits source for watering the football field. This will be done on Tuesdays and Thursdays. We are allowed to water on Sundays with the city water. We are looking at purchasing a water tank to water the softball field.

Superintendent Watson informed the board members that we had received a letter requesting us to request to terminate the TIF #2. We are in year 5 of the 25-year TIF agreement. We have retained legal counsel to advise us on our options. Legally, there are two ways a TIF terminates: the time period has expired (25 years) or all parties involved have collected all the funds. Neither has happened at this point. We have a couple of options and Mrs. Watson will get with legal counsel again.
