MINUTES AND RESOLUTION AUTHORIZING SALE OF BONDS

The Board of Education of Independent School District Number 5 of McCurtain County, Oklahoma, met in Special Session at the Superintendent's Office, Administration Building, Idabel Public Schools, 200 Northeast Avenue C, Idabel, Oklahoma, in said School District on the 25th day of September, 2023, at 6:00 o'clock p.m.

Notice of this special meeting was given in writing to the County Clerk of McCurtain County, Oklahoma at 10:08 o'clock A.m. on the 19th day of September, 2023, forty-eight (48) hours or more prior to this meeting, and public notice of this meeting, setting forth the date, time, place and agenda was posted on the door at the entrance to the Administration Building, in prominent view and open to the public twenty-four (24) hours each day, seven (7) days each week at 2:06 o'clock P.m. on the 21st day of September, 2023, being twenty-four (24) hours or more prior to this meeting, excluding Saturdays, Sundays, and State designated legal holidays, all in compliance with the Oklahoma Open Meeting Act (as attached hereto).

Said Resolution was thereupon signed by the President, attested by the Clerk, sealed with the seal of said School District, and is as follows:

RESOLUTION

A resolution fixing the amount of bonds to mature each year, fixing the time and place the bonds are to be sold, and authorizing the clerk to give notice of said sale as required by law.

Whereas, the issuance of \$300,000 of General Obligation Transportation Equipment Bonds by Independent School District Number 5 of McCurtain County, Oklahoma, has been duly authorized at an election held for that purpose;

Now, therefore, be it resolved by the Board of Education of Independent School District Number 5 of McCurtain County, Oklahoma:

SECTION 1.

That the \$300,000 of General Obligation Transportation Equipment Bonds of Independent School District Number 5 of McCurtain County, Oklahoma, voted on the 12th day of September, 2023, shall be offered for sale at the Superintendent's Office, Administration Building, Idabel Public Schools, 200 Northeast Avenue C, Idabel, Oklahoma, on the 23rd day of October, 2023, at 12:30 o'clock p.m.; said Bonds to become due:

\$75,000 in two years from their date, and \$75,000 annually each year thereafter until paid.

NOTICE OF SALE OF BONDS

In accordance with 62 O.S. 2021, § 354, notice is hereby given that the Board of Education of Independent School District Number 5 of McCurtain County, Oklahoma, will receive bids by: sealed bid, facsimile bid, electronic (Parity®) bid or similar secure electronic bid on the 23rd day of October, 2023, at 12:30 o'clock p.m., at the Superintendent's Office, Administration Building, Idabel Public Schools, 200 Northeast Avenue C, Idabel, Oklahoma, for the sale of \$300,000 of General Obligation Transportation Equipment Bonds of said School District, which Bonds will mature \$75,000 annually in two (2) years from their date, and \$75,000 annually each year thereafter until paid. The bids will be opened and read and shall be awarded at the first Board of Education meeting held after the bids are due.

Said Bonds shall be sold to the bidder bidding the lowest rate of interest the Bonds shall bear and agreeing to pay par and accrued interest for the Bonds. Each bidder shall submit with his bid a sum in cash, cashier's or certified check, electronic (wire) transfer or surety bond payable to the Treasurer of the District, equal to two (2%) percent of the amount of his bid. The Board reserves the right to reject all bids.
