seventy percent (70%) of the Board, to increase such base growth percentage by up to 7%. BE

IT THEREFORE RESOLVED that, pursuant to Neb. Rev. Stat. § 79-3405(2), the Board hereby increases the base growth percentage used to determine its property tax request authority for the 2026-2027 budget in an amount of 7%. Carried
