





CHAPTER 2
COMMISSIONS AND BOARDS
Article 7. Parks and Recreations

COMMISSIONS AND BOARDS

§2-701 BOARD OF PARKS AND RECREATION COMMISSIONERS.

(1) The Mayor and City Council of the City of Crete shall act as an ex-officio park and recreation board under Nebraska Revised Statute §16-696 and shall have the duty and authority to promote, manage, supervise, and control all recreation activities supported financially by the City to the extent funds are available.

(2) A Park and Recreation Advisory Board is hereby created to meet with and/or assist the Mayor, City Council and/or the standing Park and Recreation Committee of the City Council to consult with and/or advise the City as to matters concerning the Park and Recreation departments and activities of the City. The Board shall consist of seven (7) members who shall be appointed by the Mayor, by and with the approval of a majority vote of the City Council. Six (6) members of the Board shall be residents of the City and one (1) of the members of the Board may be a resident of the area over which the Municipality is authorized to exercise extra-territorial zoning and subdivision regulations.
