Summative Evaluations:

The past two weeks, I have been meeting with teachers who are in their summative year to discuss their summative evaluation. The conversations that happen during summatives are productive and valuable. This year, I continued a list of “stay” interview questions and received some great feedback. Since this was

year 2 of this process, I was interested to see the similarities and differences in answers, since some of the teachers went through this process last year (probationary teachers) I always look forward to these one on one conversations with staff!

NSCAS Assessment:

April begins assessment season across the state of Nebraska, so our 3rd and 4th graders are gearing up so they are ready. To prepare for state testing, we believe our reading, writing, and math curriculums are rigorous enough. We follow our curriculum for each subject area, and sprinkle in some review for skills when needed. Students are beginning to work on practice assessments to prepare for the format of NSCAS. They will also practice questions that will be similar to those they may see on the NSCAS assessment (similar format and wording). Students will also work on goal setting for the NSCAS test, focusing on effort.

Special Events:

SES has several upcoming events that are going to be very exciting! First of all, both the high school and middle school invited our students to come to the high school to watch their musicals this month. Our students will absolutely love to see the hard work of all of the high school and middle school students! We are thankful for this opportunity!

2025-2026 Kindergarten:

We are currently sitting at 90 kindergarten students for the 25-26 school year. Last year, we had 80 at this point in the year. I still anticipate more coming who have not registered. Boys Basketball ended their season with a tough loss in overtime at the Sub District Final game against Crete Thursday February 27th.

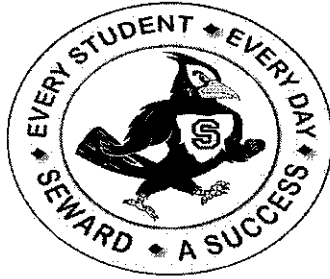

Special Education

Maintenance of Effort Compliance is a fiscal check and balance for special education funds that opened on March 3rd and closed on April 16th. Heidi and I will work together to ensure we have everything documented that may impact special education funding.

Our reviewed Policies and Procedures are due to NDE by March 30, 2025. We had no changes for the 24-25 school year.

I attended the NASES (Nebraska Association of Supervisors of Special Education) Legislative Conference in Lincoln on February 27th and 28th. I met with Senator Hughes on the morning of the 27th with the Directors of Special Education from Cennential and Milford. We were able to share information about bills we were watching and to share information with Senator Hughes about current practices in our schools involving MTSS, evaluations for special education, and special education services. Senator Hughes shared her insight into the bills that were being heard that could potentially impact special education. We appreciate her time and her insight.

On Thursday afternoon, there will be a round table on the following topics:

- Homebound placements
- Munroe-Meyer Institue Outreach
- NRS 79-11, 157 (Reading Bill)
- Writing High-Quality MDTs
- Documentation of Services Minutes
- Early Childhood Roles and Responsibilities
- Nebraska Youth Leadership Council (NYLC)

Then, on Friday, Dr. Maher with NDE staff provided an update about The Nebraska Literacy Project.

High Ability Learners (HAL)

Twenty-two second-grade students will take the Cognitive Abilities Test (CogAT) a group-administered assessment that measures a student's reasoning and problem-solving skills. This is one of the first steps in the process of HAL identification.

Title

The number of students who have received Tier II Title Reading services has remained consistent.

We will continue to monitor their progress in the classroom and their Tier II reading intervention.

Preschool

Potential preschool students for the 2025-2026 school year are invited to attend our Preschool Open House on March 21st in our preschool rooms. Children will have an opportunity to listen to a story, play, and interact with other children. If you know of families looking for a high-quality preschool for their 3-year-old or 4-year-old child please have them contact us at the elementary school to add them to the list.

Sixpence

The Grant for Sixpence is due on March 15th. Previously, we had a joint Seward County Grant with the ESU overseeing the grant for our three school districts (Seward, Milford, Centennial). We are restructuring our Sixpence Program since ESU 6 will no longer be overseeing the grant. Sixpence is a valuable resource for our communities and will continue to work to support this program in our school districts.

English Language Learners

The ELPA21 (English Language Proficiency Assessment for the 21st Century) is an important test designed to measure the English language proficiency of students identified as English Language Learners (ELL) or who are on monitor status for ELL. This annual assessment helps educators understand the progress of these students in their English language skills, ensuring they receive the support they need to succeed academically. For the upcoming testing window, which opens on January 27, 2025, and closes on March 14, 2025, our district will administer the ELPA21 to seven students.

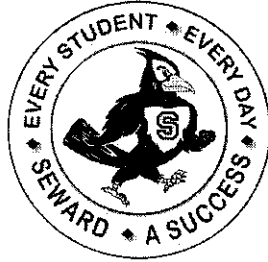

March 2025 Board Report for Curriculum and Staff Development

Board Members,

The third quarter will be coming to a close and we will start our final quarter of the 24-25 school year. It seems like this year has flown by with incredible speed, but there are so many things we are thankful for when we reflect on this year- The bottom line is we have great people all the way around- students, parents, staff and school board- Thanks for being an important part of our team!

Curriculum

The math curriculum review had a prominent spot on our February staff development day and will also be a big part of the March staff development day. In February, we unwrapped the standards, looked at sample print materials, and analyzed digital resources to narrow down the instructional programs that we will look at during our March meeting. At our meeting, I will share more information about the companies that we are looking at as well as have samples available for you. We will also have a parent open house to look at the materials prior to the April board meeting.

Instruction

Our students are currently able to access four Doane education classes to get a head start on a degree in education. For three terms, these courses were free to our students. Currently, the cost is \$150 a course- a savings of several thousands of dollars from the typical Doane cost per course. Students who do take an education course can take part in Educator's Rising which is a Career and Technical Student Organization that promotes the profession of education. Recently, three of our students participated in the state conference, and one of our students, Kathryn Naber, won the state championship. Educator's Rising is a part of our strategic plan #4- Recruiting high quality candidates to our district, and we view this as an opportunity to "grow our own" future educators.

Staff Development

Our March staff development will have a variety of training and meeting responsibilities. Our math teachers will be listening to at least 2 presentations per grade span from math curriculum publishers. These publishers were selected after a year-long process of reviewing standards, identify beliefs and philosophy statements, talking to other schools, and analyzing both digital and print samples. Our goal in March is to narrow our recommendation down to one publisher/program for the April board meeting. Our teachers will also have testing security training, an optional presentation from EHA regarding our insurance changes, a presentation regarding culture from HumanEX, action team meetings, and a district wellness committee meeting at the end of the day.

Assessment

Most of our assessments will be given in April. March is the time that all the final planning is being done with making schedules, test sessions, adding accommodations, etc. The principals do a great job supporting testing in their buildings and making this process a priority in the months of March and April.

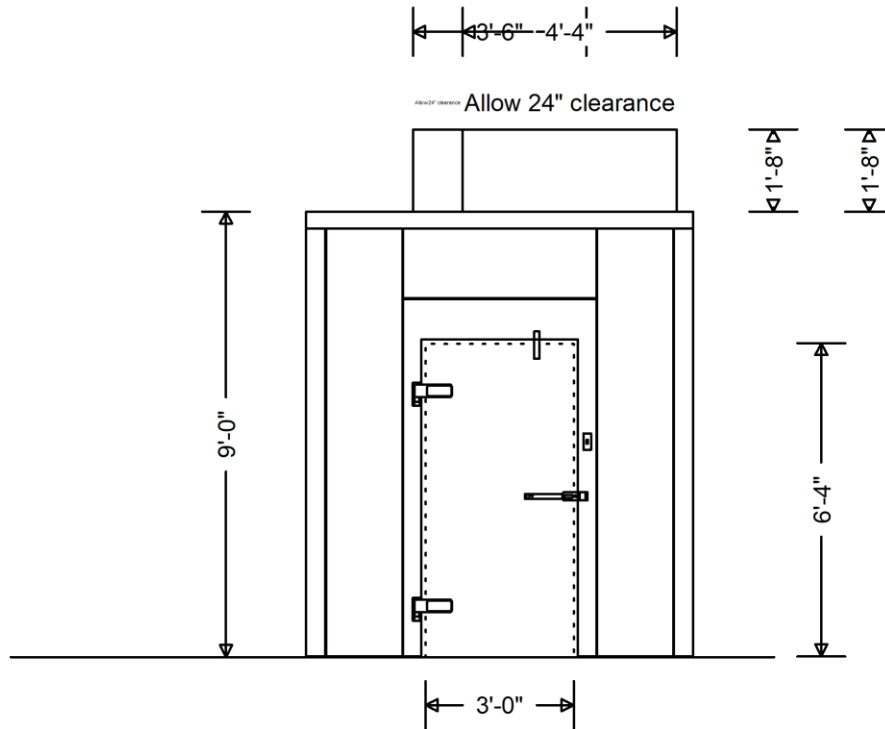
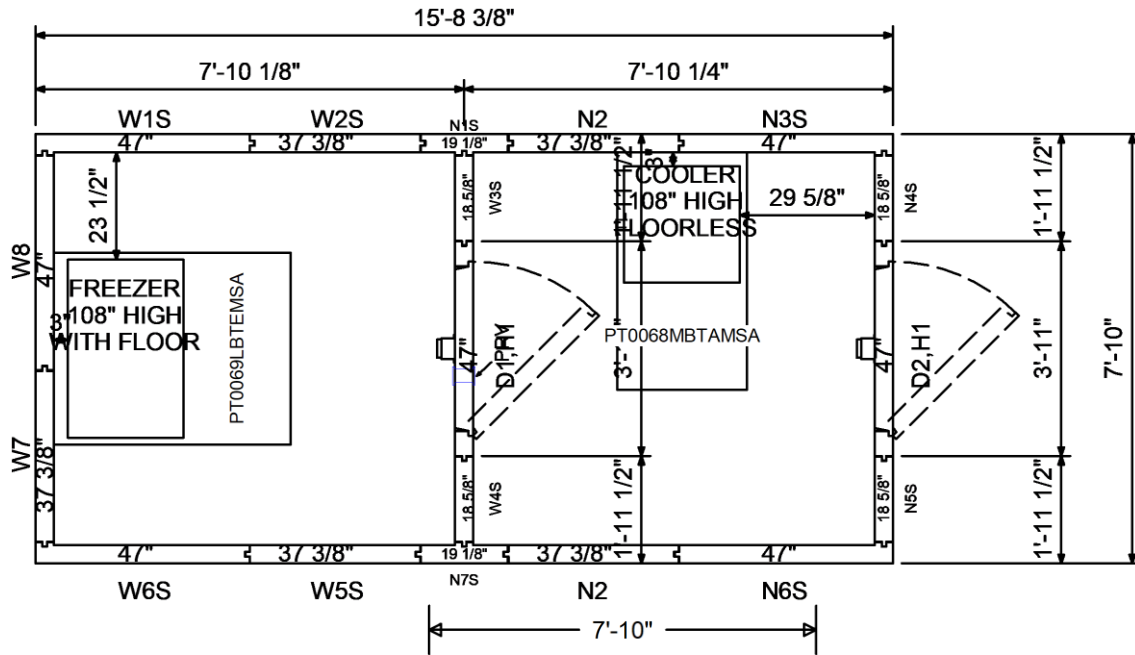
