Storage Area Network (SAN) Replacement Rationale

Last May, the school board approved the purchase of two new servers for the network. This was part one of the scheduled server infrastructure replacement. The servers were installed last summer and are performing well. As I stated in my request back in May, the second part of the project is the replacement of our SAN, an array of hard disk drives where all of our data is stored. Our current SAN is 5+ years old. Though five years may not seem old to some, when it comes to computer storage and disks that spin at 15,000 RPM 24x7x365, it is old. Recently, we had a corruption that occurred on one of our servers due to an incompatibility with the new server software we are running in conjunction with our old SAN. The corruption resulted in our student and staff files being inaccessible for almost an 18-hour period and considerable stress for the tech coordinator ☺. Thankfully no data was lost, but the support technician I worked with resolving the problem informed me that in order to completely protect ourselves from future corruption, the SAN should be replaced with a newer fully-supported model. I had originally slated this piece of equipment to be replaced next summer, but due to the possibility of future corruption I am requesting it now so I can install it over the winter. The total cost for the SAN is \$15,744.08 from Works Computing (HP Government). This cost is for the hardware and support for five years. I plan to do the setup, install, configuration, and migration of all of our data myself.
