Scenarios for transporting students:

- We are losing one route driver and possibly one activities driver. Meeting with Bill Andres, we discussed changing the routes so we have one less route to accommodate the lost of one route driver.
- The town routes will be picked up by the East or the North route driver and South route driver, which will eliminate the town route.
- The North bus route will take a couple of families from the Northwest route, which will allow the Northwest/West route to be able to use a van.
- The issue we may still have is we need to buy another larger route bus so we can eliminate the town route. Our old snub nose buses are going to be 23 years old and are starting to fail us. A newer bus will be more reliable for a bus route.
- We can't use anymore of our custodians to do routes or I will not be able to use them for activities. I will only have three custodians to do activities during the week at this time. On the weekends will not be a problem.

2011 -2013 used yellow bus with 60 - 71 capacity will cost us 50,000 - 60,000. Lower miles 30,000 to 45,000 miles.

It is cheaper to provide transportation for families over paying for them to travel to school but not by much. A newer route bus will need to be purchased if we continue transporting students. In the future we will need to send some buses to the "bone yard" and rotate some of our better buses out. I don't want to keep them until they die like we have in the past.
