All proceedings of the Board of Education, except as may be hereinafter noted, were taken while the convened meeting was open to attendance of the public.

1. McCook Public Schools Board President, Tom Bredvick, called the June 10, 2019 MPS Board of Education meeting to order at 6:30 p.m. Roll call with the following members being present: Dennis Berry, Tom Bredvick, Loretta Hauxwell, Brad Hays, Mike Langan, and Teresa Thomas. Absent: None.

Recognition of Open Meeting Law poster was noted, and the Pledge of Allegiance was recited.

2. Reports, Communications & Public Participation

The Board heard a presentation from Nathan Hudson on the proposed band trip to New York City in May 2020. Total cost of the trip is estimated to be \$82,000 and each individual student would pay approximately \$1,100. The students have been fundraising and will need to continue to do so. Currently 47 students and parents have indicated they will participate and expect more to sign up during band camp.

No one spoke at public forum.

4. Reports from Staff Members and Committees

Teresa Thomas reported on the activities committee meeting. Several items were discussed including select choir participation, event scheduling, travel and time missed from school, and coaches attending state tournaments. It was noted that over 79% of the students are involved in some extra duty activity.

5. Board and Administrative Comments

Mr. Norgaard discussed the certification of state aid to schools. McCook Public Schools will receive \$473,083 more for 2019-20 school year than what was received for the 2018-19 year. This number was reduced from the original estimates for state aid that were provided earlier in the legislative session. The bulk of the increase is due to a change in the cost group comparison and a positive option enrollment numbers.

Mr. Brazell stated that the district has been looking at ways to save funds. One such way is to reduce energy costs and the most likely method to do this is to change over to LED lights. The plans are to advertise for a Request for Qualifications (RFQ), and apply for an energy loan with Nebraska Energy Office. Once those are received a committee will review and will return to the Board, probably in August to review the proposals and make a final decision if to move forward. Also considered was the addition of front end controls for the HVAC system. These may or may not be included due to the cost of the controller.

Under Board comments Dennis Berry commented that the TEEOSA state aid formula needs to be reworked and this is not fair to all schools. All school board members need to stay in touch with their local senator and those senators on the finance committees. Loretta Hauxwell stated that she will not be in attendance at the July 8<sup>th</sup> meeting.
