At the beginning of the meeting the chairperson announced and informed the public that a current copy of the Open Meetings Act was posted on the west wall of the meeting room.

4. Reports from Staff Members and Committees  
Policy Committee: Loretta Hauxwell reported that the policy committee meet and reviewed the policy being presented tonight. The committee needs to spend time working on organizing the policies. The committee will wait until after the state school board convention to convene and review.

Board member Mike Langan arrived at 6:40 pm.

AQuEST & NSCAS Presentation:

Superintendent Norgaard presented on the process schools in Nebraska use to demonstrate accountability and assess student growth. He discussed how it came out of LB438 in 2014 and how the Nebraska process also meshes with Federal ESSA requirements. Schools take the assessments and are rated as Excellent, Great, Good, or Needs Improvement. Priority schools are the lowest ten schools that need improvement. Ninety-eight school buildings across the state have the opportunity through EBA (Evidence Based Analysis) to "bump" up to the next level. McCook High School is one of them. The administrative team spent the greater part of the last two weeks documenting and preparing information to submit to NDE outlining the high school's and the district's success in meeting the excellent standard of the six tenants of AQuEST. The Information was submitted will hopefully present enough evidence to bump the high school from "Good" to "Great".

Information was also presented on NDE's plan to integrate additional state assessments into the process.

5. Board and Administrative Comments

Mr. Norgaard stated that a lot of time and effort went into AQuESTT EBA process to prove to an external team that McCook schools are excellent.

He also reminded the board of the State Education Conference in Omaha on Nov 20 to 22, 2019.

In the Business Manager Comments Mr. Brazell stated that the Annual Financial Report (AFR) and the SPED Final Financial Report (FFR) are almost completed. Both reports have new formats this year and required additional time and effort to reconcile and upload to NDE. He also reported that the district has started the process of looking for an activity bus.

In the Board Comments Dennis Berry commented on the tremendous amount of work the administrative team put in on the EBA work and that this takes away from that time that could be spent doing something better. He appreciated the hard work but thought it was a "waste of tax payers' dollars."

Tom Bredvick stated that the State Education Conference is in Omaha on November 21 and 22.

6. New Business

Tom Bredvick moved and Mike Langan seconded to approve the Superintendents increase in total compensation by 2.23%.

Tom commented that this year he met with the new board members to review the process, instead of meeting with the vice president and secretary of the board.

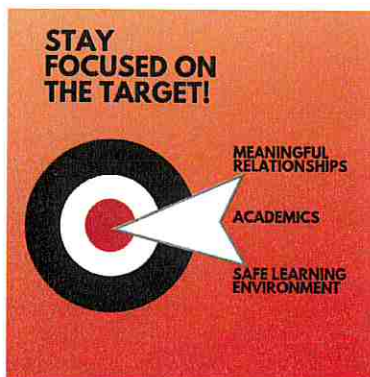

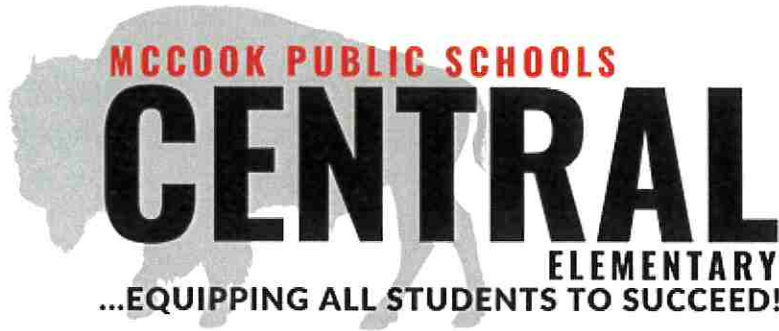

- We had a PBIS audit this past week. I'm still waiting on our results. PBIS is split up into 3 tiers of support similar to RtI. We actually use RtI for both Academic and Behavior interventions. Tier I is for every student in the classroom. Tier II supports are for some kids that need extra help/interventions and Tier III is for a few kids that struggle. Tier III is intensive focus on those kids for academic or behavior help. Our audit will help us gauge where we can improve and see what we do well in.

- November 20th is our vertical PLC day. We will split up staff into K-12 curriculum teams to make sure we don't have any gaps and unneeded overlaps in what we are teaching to mastery.

- 1) SPED Proportionate Share Application for Nonpublic Schools application is completed...the district receives \$33,377 in federal IDEA funds to help pay for sped services at the nonpublic schools, which includes St. Patrick's school, private preschools in the district, and kids with disabilities in home schools within district boundaries.
- 2) Our new school psychologist intern Elizabeth Lopez-Rivas and I attended the SPED Law conference last week, which was an excellent reminder/training.
- 3) Mr. Paul Calvert, ESU 15 administrator, asked if my wife and I would like to go to the National ESU Conference in Phoenix, AZ the first week of December, we obliged and will be attending that December 4-7 with some ESU 15 board members/spouses and Todd Weimer, Tech Director and his wife and Mr. and Mrs. Paul Calvert.
- 4) SPED Teachers are doing a great job of doing whatever it takes to help kids progress to the next level of their learning.
- 5) Functional Behavior Assessment (FBA) training with all sped teachers, counselors and possibly administrators, at the request of the principals on Wednesday, Nov. 20th at McCook Elementary library at 2:30 PM. I will help Samantha Shiers, DLC teacher, who is working on completing her administrative endorsement, and Elizabeth Lopez-Rivas, who needs to do a staff presentation for her School Psych internship, prepare and present the training.
- 6) Annual sped Targeted Improvement Plan (TIP), required of all districts in Nebraska, is complete, and the goal met. Our focus for improvement is to improve reading for students with disabilities in the current 6th grade. The goal is to have at least 30% of the 18 students improve their MAPS reading score from Fall 2018 to Spring 2019 assessments. The actual rate far exceeded the goal (NDE encourages us to set our TIP goals low)...72%.
- 7) I attended a meeting for SPED Directors in Lincoln on 10/25...one item of discussion was how NDE arrives at designating certain schools TSI, ATSI or CSI. Here's the notes
  - i) If a district is designated TSI, or ATSI, or CSI, they need to come up with a plan to improve...this can be done through the required annual TIP.
  - ii) It's an Every Student Succeeds Act (ESSA) requirement
  - iii) 274/1009 (27%) total school buildings across the state received TSI, ATSI, or CSI status for their students with disabilities student group.
  - iv) The biggest student group out of the 10 available student groups was SPED.
  - v) NDE wants the formula complicated so the newspapers can't rank the schools across the state.
  - vi) Based solely on NSCAS assessments for students with disabilities.
  - vii) Lane is available to discuss/walk through a district's designation with anyone who contacts him [lane.carr@nebraska.gov](mailto:lane.carr@nebraska.gov)

1. Lighting & Heating & Air Conditioning project (Meeting with TRANE)
  - a. It must meet energy saving criteria
    - i. Substantially reduced consumption
  - b. This is the time to do lighting due to financial reasons
  - c. We don't have final engineer or pricing - this is an update
  - d. We have a short time frame due to the changes in the funding after the first of the year
  - e. Discussed the type of lighting - LED
  - f. Least expensive school to operate per square foot is Central (.52) and the most expensive is McCook Elementary (1.26)
    - i. Jr. high (1.10) and high school (.72) are in between these two
  - g. The goal is to operate the system better than they do now
    - i. Discussed the locations and costs associated
    - ii. We have some issues with our heating and air across the district
      1. We need to do some upgrades with controls and equipment that will be costly.
  - h. Loan amount is around \$500,000 on up to a 15 year loan
    - i. These dollars will be needed over the next 5 years to take care of the issues with our systems and to reduce energy costs associated with lighting.
  - i. A Local bank will need to be identified
    - i. Specific banks do qualify to give these type of Nebraska Energy Office (NEO) loans
  - j. The re-commissioning process will give a great deal of information that can really help us focus.
    - i. This process will help us prioritize what projects to do first and which can wait
  - k. Low energy costs will impact the cost to the district.
  - l. Agenda item for discussion at the board meeting on the 11th
  - m. We may need to select a date for a special meeting to approve the project and bank if there is consensus to move forward
2. Desks for Central
  - a. Fundraising
    - i. Main purpose was to give people a reason to come together, but if we can also raise a little money to buy some newer desks that would be good.
    - ii. We do have enough desks for all of our students
